**Project Title:** Hum-101 Drainage North Project, EA 01-0H650 (Lake or Streambed Alteration Agreement No. EPIMS-HUM-48237-R1C)

**Project Location:** The Project is located in Humboldt County on U.S. Highway 101 between post miles (PMs) 60.68 near the town of Fortuna and PM 136.39 near the Humboldt and Del Norte County lines.

**Project Description:** The California Department of Fish and Wildlife (CDFW) has executed Lake and Streambed Alteration Agreement (EPIMS-HUM-48237-R1C), pursuant to Fish and Game Code section 1602, the project Applicant is the California Department of Transportation.

This Agreement authorizes the California Department of Transportation's drainage system repair and replacement activities at 14 locations along US Route 101 in Humboldt County between PM 60.68 and PM 136.39.

This is to advise that CDFW, acting as a Responsible Agency, approved the project described above on 10/23/2024 and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
2. CDFW considered the Negative Declaration prepared by the Lead Agency for this project pursuant to California Code of Regulations section 15096, subdivision (f).
3. Mitigation measures were made a condition of CDFW's approval of the project.
4. A Mitigation Reporting or Monitoring Plan was not adopted by CDFW for this project.
5. A Statement of Overriding Considerations was not adopted by CDFW for this project.
6. Findings were not made by CDFW pursuant to California Code of Regulations section 15091.
