Aharin Coke is seeking a Major Use Permit from the County of Lake, for a proposed A-Type 3 "medium outdoor" commercial cannabis cultivation operation at 9840 Rock Creek Road near Lower Lake, California on Lake County APN 122-251-15 (Project Parcel). The proposed commercial cannabis cultivation operation would be composed of a 43,500 sq. ft. fenced outdoor cannabis canopy area, four 160 sq. ft. harvest storage areas, a 120 sq. ft. Security Center/shed, and four water storage tanks. Water for the proposed cultivation operation would be provided by an existing onsite groundwater well.
