Project Description: The project proposes to develop a 10.46-acre portion of the 10.9-acre site located at 350 West Trimble Road with a 50-foot-high, 208,000-square-foot manufacturing and assembly building that would include 15 loading docks on the southern building façade. Approximately 188,000 square feet of the proposed building would be dedicated to light manufacturing and assembly, with the remaining 20,000 square feet dedicated to office space.
