**Project Title:** Graves Stream Crossings, Pond Remediation and Water Diversion Project (Lake or Streambed Alteration Agreement No. EPIMS-HUM-27002-R1C

**Project Location (include county):** The project to be completed is located within the Roach Creek watershed, approximately 9.8 miles southeast of the town of Orick, County of Humboldt, State of California. The project is located in sections 10 and 11, T9N, R2E, Humboldt Base and Meridian; in the Bald Hills U.S. Geological Survey 7.5-minute quadrangle; Assessor's Parcel Numbers 532-056-009 and 532-055-002; latitude 41.185740 N and longitude 123.923309 W at the center of the parcels.

**Project Description:** The California Department of Fish and Wildlife has executed Lake and Streambed Alteration Agreement number EPIMS-HUM-27002-R1C, pursuant to Section 1602 of the Fish and Game Code to Mr. Seth Graves.

The project is limited to five encroachments. One encroachment is for water diversion, for domestic use only, from unnamed tributaries to Roach Creek. Work for the water diversion will include upgrade, use and maintenance of the water diversion infrastructure. The four other encroachments are to upgrade existing stream crossings and ponds. Work for these encroachments will include some or all the following: excavation, culvert removal, culvert installation, backfilling and compaction of fill, and rock armoring as necessary to minimize erosion.
