Notice is hereby given that the County of Fresno has prepared Initial Study Application (IS) No. 8340 pursuant to the requirements of the California Environmental Quality Act for the following proposed project:

INITIAL STUDY APPLICATION NO. 8340 and UNCLASSIFIED CONDITIONAL USE PERMIT NO. 3754 filed by **NICK TAGAS** proposing to allow the installation of a new unmanned telecommunications facility consisting of a 105'foot-tall monopole wireless communication tower (monopine design) with related facilities on a 50' x 50' fenced site leased area of a 5-acre parcel in the RR (Rural Residential, two-acre minimum parcel size) Zone District. The subject parcels are located on the south side of the intersection of E Trimmer Springs Rd and Sunnyslope Rd. within the unincorporated community of Trimmer (Pine Flat). (APNs: 153-200-30,(-31 & -32) (Sup. Dist. 5).

(hereafter, the "Proposed Project")

The County of Fresno has determined that it is appropriate to adopt a Mitigated Negative Declaration for the Proposed Project. The purpose of this Notice is to (1) provide notice of the availability of IS Application No. 8340 and the draft Mitigated Negative Declaration and request written comments thereon; and (2) provide notice of the public hearing regarding the Proposed Project.
