The applicant is requesting approval of a tentative map to subdivide the subject 10-acre parcel into two 5-acre parcels (Parcels A & B). An existing private roadway (Wildhorse Road) would provide vehicular access to the subdivision. No development is immediately proposed for project, however, the vesting tentative map has identified potential building sites for the future construction of a single-family residence and Accessory Dwelling Unit (ADU) on each resultant parcel. The project includes an exception request from Division 914 of the County Ordinance Code whereby the project proposes to retain and treat stormwater on site in lieu of the Collect and Convey requirements specified in the code.
