BACKGROUND:

Pursuant to Section 15105 of the California Environmental Quality Act (CEQA) Guidelines, the public review and agency comment period is extended for the Draft Environmental Impact Report (EIR) for the H Cycle Pittsburg Renewable Hydrogen Project, AP-22-0078 (proposed project).

The original Notice of Availability (NOA) for the proposed project, posted on January 22, 2024 (SCH No. 2023040173), indicated a public review and comment period deadline of March 6, 2024, at 5:00 p.m.
