Project Location: The Project is located at 300 Pioneer Street, Santa Cruz, CA 95060 in Santa Cruz County.

Project Description:

The Department of Cannabis Control, pursuant to authority granted under Business and Profession Code Division 10, Chapter 2, Section 26012, approved a Cannabis Distributor License submitted on 09/27/2021 by William Sump.

Project Activities:

The Project will consist of a cannabis distribution business located at 300 pioneer street, Santa Cruz, CA 95060. The APN is 001-172-18. It will operate within an existing building 1200 SF building that sits on a 4.06 acre parcel. Proposed distribution operations will include storage of cannabis products generated on site for analytical testing, final packaging of products post testing, and transportation from the site to another licensed distributor, manufacturer, or retailer. Two vehicle trips are anticipated daily. Additional trips are anticipated to occur from a testing laboratory.

Reasons Why Project is Exempt:

The Department of Cannabis Control has determined that the project is a Class 1 Categorical Exemption Project. Class 1 Categorical Exemptions consist of the operation, repair, maintenance, permitting, leasing, licensing, or minor alterations to existing public or private structures, facilities, mechanical equipment, or topographical features, involving negligible or no expansion of use beyond that existing at the time of the lead agency's determination. The Project involves the use of an existing industrial building with no proposal for building expansion. The design, location, size, and operating characteristics of the Project are compatible with the existing and future land uses within the vicinity as it is zoned light industrial zoned. None of the exceptions to the exemption defined in Section 15300.2 apply to the Project.
