

Notice of Public Hearings for the Draft Environmental Impact Report for SR 47 Vincent Thomas Bridge Deck Replacement Project



What is Being Planned?

The California Department of Transportation (Caltrans) has prepared a Draft Environmental Impact Report/Environmental Assessment (EIR/EA) to analyze impacts of a full or partial closure of the Vincent Thomas Bridge to replace the deteriorated bridge deck on State Route 47 (SR-47). Although the bridge is structurally sound, the bridge deck is rapidly deteriorating. This is due to concrete fatigue caused by heavy traffic loading, as well as environmental deterioration due to age and the marine environment. Built in 1963, the Vincent Thomas Bridge is a steel, suspension bridge spanning 6,062 feet and is the main gateway to the Port of Los Angeles. The purpose of the proposed project is to preserve the structural integrity of the Vincent Thomas Bridge by replacing the bridge deck and seismic sensors, and upgrade the fencing and existing median/railing barriers to meet current Manual for Assessing Safety Hardware (MASH) requirements to ensure the Vincent Thomas Bridge remains a safe and reliable corridor between San Pedro and Terminal Island in the Port of Los Angeles.

Why This Notice?

The purpose of this public hearing notice is to solicit comments from public agencies, private entities, and interested individuals regarding potential social, economic, and environmental issues related to the project. A Draft EIR/EA is available for public review and comment in conformance with the California Environmental Quality Act. We want to hear your thoughts and welcome your participation.
