Butte County proposes to enter a 12-year (17 year with optional 5-year extension) Streambed Alteration Agreement with CDFW for the ongoing implementation of routine maintenance activities within jurisdictional improved and unimproved stream channels and drainage facilities, and their associated CDFW jurisdictional areas within 200 feet of County-maintained roads. Maintenance activities will include removal, replacement, or repair of facilities; channel alignment maintenance; conversion of concrete-lined channels; debris or obstruction removal; silt, sand, or sediment removal; vegetation control in channel or on banks; goat/sheep grazing; minor erosion control work; repair of previous erosion control work; bridge washing, graffiti removal, and painting; water diversions; and geotechnical sampling and subsurface cultural resource sensitivity testing.
