The Department of Cannabis Control, pursuant to authority granted under Business and Profession Code Division 10, Chapter 2, Section 26012, approved a Cannabis Non-Storefront Retail License submitted on 12/14/2022, by Mia Morris. EVERGREEN SUPPLY CO LLC applied for a non-storefront retail license out of an existing facility located at 30 PAMARON WAY, SUITE 205, NOVATO, CA 94949 (APN 157-441-38). The applicant will store cannabis products for non-storefront retail in 258 square foot facility.

Project Activities:

The Project will consist of 258 square feet of cannabis delivery activities. The project will not expand the existing structure and no modifications were necessary. The project will utilize PG&E for energy, with no increase in usage expected.
