The Department of Cannabis Control, pursuant to authority granted under Business and Profession Code Division 10, Chapter 2, Section 26012, approved a Cannabis Small Mixed Light Tier 1 License.

Project Activities:

The project consists of a Small Mixed Light Tier 1 license with approximately 9600 square feet of canopy and 3000 square feet of immature plant area. The project will use light deprivation with no artificial lights used.
