Combined Development Permit would consist of: 1) Use Permit and Design Approval to allow construction of a 57,560 square foot mini storage facility; 2) Use Permit to allow removal of five (5) protected oak trees, one of which is a landmark tree; 3) Use Permit to allow development on slopes in excess of 25 percent, consisting of regrading 4,965 square feet of manmade slopes; and 4) Use permit to allow two on-site advertising signs totaling 35 square feet in aggregate.
