The Project site is located along Ashley Way, in the City of Colton, County of San Bernardino, California, on Assessor Parcel Numbers 0276-131-92 and 0276-131-90. The Project site consists of two existing buildings at 855 Ashley Way Building and 755 Ashley Way, respectfully. The Project includes a 35,000 square foot addition to the existing 855 Ashley Way building which would result in a new total building area of 100,154 square feet. The Project would also require a lot line adjustment and partial demolition of two service bays at 755 Ashley Way. The Project would include 363 parking spaces that would be shared by both buildings and would be located in the middle and eastern portions of the Project site. The Project is anticipated to be completed in one phase.
