Description of Nature, Purpose and Beneficiaries of Project:

The project is an approximately 31-acre prescribed fire to be implemented by the Yolo County Resource Conservation District. This prescribed burn is funded by CAL FIRE's Fire Prevention Grant to the Yolo County RCD, with the primary goal to provide education and training to landowners in high wildfire risk areas of Yolo County to use prescribed fire as a land management tool. Prescribed fire decreases fuel continuity, reduces the probability of catastrophic wildfires, and promotes a healthy ecosystem. The proposed prescribed burn would be led by a California Certified Burn Boss and would serve as a demonstration training burn for members of the Yolo Prescribed Burn Association to learn how to safely and effectively use prescribed burning for hazardous fuels management, invasive weed control, and for the benefit of the ecosystem.

The management objectives for the proposed prescribed burn are invasive species control, improved forage for rangeland, and wildfire prevention. The proposed project would take place on rangeland for cattle impacted by yellow starthistle (*Centaurea solstitialis*) and barbed goatgrass (*Aegilops triuncialis*). Yellow starthistle and barbed goatgrass are both unpalatable to cattle and can cause injury to grazing animals. These two invasive weeds are winter annuals that degrade livestock grazing and wildlife habitat through their aggressive and dense growth. To properly control goatgrass, a subsequent burn the following season will be needed.

The proposed project benefits private landowners, suppression resources, and the ecological integrity of the state's rangeland. This project was approved by Yolo County RCD on July 1, 2022.

The site is located at the base of the eastern ridge that forms the Capay Valley. The proposed unit is located in agricultural rangeland in rural Yolo County historically categorized as oak savannah and grassland. The burn plan, prepared by a California Certified Burn Boss, will identify hazard mitigation tactics and ensure the conservation of ecological and cultural resources. To define the perimeter of the burn, site preparation for the project may include mowing or box scraping with a tractor along existing two-track roads depending on vegetation conditions. Under the specified prescription, the burn will have low velocity and minimal heat resulting in the combustion of fine fuels only. The project will not result in taking of endangered, rare, or threatened plant or animal species or result in significant erosion and sedimentation of surface waters. 
