

The Project will rehabilitate ten street segments in Kingsburg. The work to be done consists, in general, of surface preparation, type II slurry seal, pavement striping, markers and markings, and utility protection

1. Surrounding land uses and environmental setting: Briefly describe the project's surroundings:

All of the street segments are within residential areas of Kingsburg.

2. Discretionary approval authority and other public agencies whose approval is required (e.g., permits, financing approval, or participation agreement.)

A City of Kingsburg encroachment permit will be required (construction equipment access and traffic control).
