Project Description:

The Department of Cannabis Control, pursuant to authority granted under Business and Profession Code Division 10, Chapter 2, Section 26012, approved a Cannabis Microbusiness License submitted on 4/24/2018, by Joshua Santaga. JN Development applied for a microbusiness license out of an existing facility located at 1761 Smith Ave, San Jose, CA 95112 (APN 477-26-021). The applicant will store cannabis products for manufacturing, retail, distribution, and cultivation in 6,375 square foot facility.

Project Activities:

The Project will consist of 6,375 square feet of cannabis retail, distribution, manufacturing, and cultivation activities. There will be no expansion, minor interior modifications, and utilize all public services and utilities.

Reasons Why Project is Exempt:

The Department of Cannabis Control has determined that the project is a Class 32 Categorical Exemption Project. Class 32 Categorical Exemptions consist of being consistent with the City's General Plan and Zoning Code, located within the city limits, project is no more than five acres, substantially surrounded by urban uses, no value as habitat for endangered, rare, or threatened species, no result in any significant effects relating to traffic, noise, air quality, or water quality, and is adequately served by all public utilities. None of the exceptions to the exemption defined in Section 15300.2 apply to the Project.
