<u>DESCRIPTION OF NATURE AND PURPOSE OF THE PROJECT</u>: Conditional Use Permit (CUP) for a Type 21 Liquor License at an existing market. The 0.23-acre site is located at 3070 Reynard Way in CN-1-3 Zone, Airport Influence Area (San Diego International Airport and Naval Air Station North Island), and a Fire Brush Zone within the Uptown Community Plan area and Council District 3. REASONS WHY PROJECT IS EXEMPT: The City of San Diego conducted an environmental review and determined that the project would qualify to be categorically exempt from CEQA pursuant to Section 15301 (Existing Facilities). Section 15301 allows for the operation, repair, maintenance, permitting, leasing, licensing, or minor alteration of existing facilities (public or private), involving negligible or no expansion of use beyond that existing at the time of the determination. Since the project would only permit a liquor license that would not expand the use of the market the exemption was deemed appropriate. The project is located on a developed site and no environmental impacts would occur and none of the exceptions described in CEQA Guidelines Section 15300.2 apply.


