Major Use Permit (UP 22-24) for a private campground with 16 campsites and a special event venue for weddings and private gatherings at 5680 Blue Lakes Road, Upper Lake, CA. At full build-out, the Project would include: Main parking lot with 40 marked gravel parking spaces; fire truck turn around; an outdoor stage and noise suppression sound wall; a water fountain; 16 gravel sites with electricity and hose bibs; a restroom; office and barn. Operation would be from April to October. The campground and venue will be private by appt. only and can be used with the Venue for special events. Hours of operation for special events would be primarily on weekends (Friday through Sunday) from 7:00 a.m. to 10:00 p.m., depending on each event's needs. Amplified music will be turned off by 9:45 p.m. One event is anticipated per week with up to 250 guests. The project is restricted to 40 vehicles on-site at any one time.
