Project Location: The Project is located at 3301 S HARBOR BLVD, UNIT 106, SANTA ANA, CA 92704, in Orange County.

Project Description:

The Department of Cannabis Control, pursuant to authority granted under Business and Profession Code Division 10, Chapter 2, Section 26012, approved a Cannabis Distribution License submitted on 7/18/2022, by An Nam Tran. SOLEX DISTRIBUTION GROUP, INC applied for a distribution license out of an existing facility located at 3301 S HARBOR BLVD, UNIT 106, SANTA ANA, CA 92704 (APN 414-221-23). The applicant will store cannabis products for distribution in 5,700 square foot facility. Non-volatile manufacturing will also occur on site.

Project Activities:

The Project will consist of 5,700 square feet of distribution and manufacturing activities. The project will not expand the existing facility and no modifications were necessary due to a reuse of activities on site.

Reasons Why Project is Exempt:

The Department of Cannabis Control has determined that the project is a Class 1 Categorical Exemption Project. Class 1 Categorical Exemptions consist of the operation, repair, maintenance, permitting, leasing, licensing, or minor alterations to existing public or private structures, facilities, mechanical equipment, or topographical features, involving negligible or no expansion of use beyond that existing at the time of the lead agency's determination. The Project involves the use of an existing industrial building with no proposal for building expansion. The design, location, size, and operating characteristics of the Project are compatible with the existing and future land uses within the vicinity as it is zoned light industrial zoned. None of the exceptions to the exemption defined in Section 15300.2 apply to the Project.
