The applicant requests approval of a Land Use Permit to establish a 2.83 MW commercial solar facility and 3.7MW battery storage system on the subject property, interconnecting to existing PG&E electrical distribution system via utility poles adjacent to the site. The project includes an exception request from Chapter 914-2 of the County Ordinance to allow the existing drainage pattern to remain, where diversion within an adequate storm drainage system to an adequate natural watercourse having a definable bed and banks or to an existing adequate public storm drainage system is required.
