Description of Nature, Purpose and Beneficiaries of Project:

DWR staff will use a road grader, dump truck, water truck, and roller to grade the dirt and gravel road between Byron Highway and DFD Headworks above Banks Pumping Plant. Roadways will be graded and rolled to return surfaces to original designed specifications. Approximately 5,000 yards of ¾" road aggregate will be added to the dirt road and gravel road for finished roadway surface. Equipment will be staged inside secured fenced in areas when not in use. All work is within DWR right of way.
