PROJECT LOCATION: The project site is located at 2223 Gunn Road, on the west side of Gunn Road and approximately 1,600 feet south of El Camino Avenue, in the Carmichael community of unincorporated Sacramento County.

DESCRIPTION OF PROJECT: The previously approved project included the following entitlement requests:

- 1. A **Tentative Parcel Map** to divide 0.77 acres into four lots in the RD-5 zone.
- 2. A **Special Development Permit** to allow more than two lots to be served by a private drive.
- 3. A **Design Review** to comply with the Countywide Design Guidelines.

The current project is an extension of time consisting of a six-year extension for the previously approved Tentative Parcel Map. The entitlement required is as follows:

A **Time Extension** pursuant to Section 22.20.090 and 22.20.095 of the Sacramento County Code to extend, by six years, the expiration date of a Tentative Parcel Map, known as 2223 Gunn Road (PLNP2019-00045), which involves the division of 0.77 acres into four lots in the Residential (RD-5) zoning district in the Carmichael/Old Foothill Farms Community of unincorporated Sacramento County.
