The Project at 457, 461, 465, and 467 West Del Norte Street includes four (4) separate three (3) story single-family residences and four (4) detached two-car carports on four (4) adjacent vacant lots totaling .41 acres. The Project includes a 2,085 square foot, 44 feet 9 inch home on a 4,617 square foot lot, a 2,100 square foot, 45 feet home on a 4,543 square foot lot, a 2,100 square foot, 45 feet home on a 4,471 square foot lot, and a 2,199 square foot, 44 feet 11 inch home on a 4,399 square foot lot. The Project proposes 366 cubic yards of grading, the removal of 28 trees and shrubs (two (2) Protected Toyon, 14 Protected Walnuts and Oaks, and 12 Significant various species Trees). Entitlements include reduced right of way, paving, side yards, passageways, setback, building separation, as well as, increased fence height in a front yard.
