Project Title: Wanket Recycled Water Line Project

Project Location – Specific: The project is located in the Encinitas Ranch neighborhood within Quail Gardens Drive, a portion of the Encinitas Ranch Golf Course, and an existing above ground water tank (see Attachment 1, Figures 1 through 3). The project site occurs within portions of Assessor's Parcel Numbers (APNs) 254-610-01, 254-611-08, and 254-611-11.

Description of Nature, Purpose and Beneficiaries of Project:

The project entails installation of 1,000 feet of new 16-inch diameter recycled water pipeline from the existing Wanket Tank, through the Encinitas Ranch Golf Course, and to an existing 8-inch diameter recycled water pipeline in Quail Gardens Drive. Electrical utility connections within Quail Gardens Drive and service to Wanket Tank site will also be completed. See Attachment 1 for additional details on the project description.
