Brief Description of the Project: Grading Permit (#ENG23-00002) for land disturbing activities on land with slopes over 10% involving the clearing of nonnative grassland within a fallow vineyard, grading and construction of an approximately 75-acre-foot off-stream agricultural water storage reservoir that would store reclaimed water from Napa Sanitation District within an approximate 6.5-acre development area on an approximate 223.94-acre parcel adjacent to the Sonoma County line in the Carneros region, approximately 4.5 miles southwest of the City of Napa and within the Napa River Marshes West and the Huichica Creek watersheds.
- 9. The project site is not located on the lists enumerated under Section 65962.5 of the Government Code, including, but not limited to lists of hazardous waste facilities.

## PRELIMINARY DETERMINATION:
