
Project Description: The California Department of Fish and Wildlife (CDFW) has executed Streambed Alteration Agreement (EPIMS-SLO-37894-R4), pursuant to Fish and Game Code section 1602, to the project Applicant, California Military Department.

The Project involves activities related to the demolition of the existing Kern Avenue Bridge (Bridge No. 3) over Dairy Creek and replacement with a two-lane bridge structure with sidewalk to provide improved safety and operations.

This is to advise that CDFW, acting as a Responsible Agency, approved the project described above on 2/6/2024, and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
2. CDFW considered the Mitigated Negative Declaration prepared by the Lead Agency for this project pursuant to California Code of Regulations section 15096, subdivision (f).
3. Mitigation measures were made a condition of CDFW's approval of the project.
4. A Mitigation Reporting or Monitoring Plan was adopted by CDFW for this project.
5. A Statement of Overriding Considerations was not adopted by CDFW for this project.
6. Findings were not made by CDFW pursuant to California Code of Regulations section 15091.
