Project Description:

The Department of Cannabis Control, pursuant to authority granted under Business and Procession Code Division 10, Chapter 2, Section 26012, approved Cannabis License submitted on 07/03/2018, by Jason Zumalt. Jason Zumalt applied for a Small Mixed-Light Tier 1 license.

Project Activities:

The proposed Project consists of an existing mixed-light tier 1 cannabis cultivation site with 10,000 sq. ft. of canopy, immature plant area, and processing activities. The Project site will utilize a groundwater well and water diversion for cannabis irrigation. The proposed Project site is located within a zoning district that allows for commercial cultivation, predominately forested with natural clearings where the residence and cultivation sites are located.
