<u>Description of Nature, Purpose, and Beneficiaries of Project:</u>

The proposed activity is part of a USDA-Natural Resource Conservation Service costshare funded project with The McConnell Foundation that will expand off-stream livestock water on a year-round cattle-grazing ranch with the overall benefit of reducing negative impacts of cattle watering directly from watercourses. The project includes tying into an existing gravity-fed livestock watering system and trenching 1,965 feet of pipeline to provide livestock water to a new 500-gallon trough in an adjacent field where cattle currently water directly from creeks.

Exempt Status:

The California Regional Water Quality Control Board, Central Valley Region has determined that the Project is categorically exempt from review under CEQA pursuant to California Code of Regulations, title 14, article 19, section 15304 (Minor Alterations to Land). Class 4 consists of minor public or private alterations in the condition of land, water, and/or vegetation which do not involve removal of healthy, mature, scenic trees except for forestry and agricultural purposes.

Reasons why Project is Exempt:

This project is Categorically Exempt under CEQA section 15304 because the Project involves minor alterations to land with no removal of healthy, mature, or scenic trees.
