The project site is located on the west side of Bald Mountain Rd., approximately 1,074 feet south of its intersection with Auberry Rd, and approximately 17 miles north of the City of Clovis (APN: 128-740-07) (42140 Bald Mountain Rd.) (Sup. Dist. 5).

This proposal entails the expansion of existing unmanned observatory structures authorized by Classified Conditional Use Permit No. 3467, which are located on a 4.95-acre parcel in the R-R (Rural Residential, two-acre minimum parcel size) Zone District. The existing unmanned observatory facilities are comprised of eight 120 square-foot structures, two 480 square-foot structures, and four 1,008 square-foot structures, each of which contain telescopes and cameras that are remotely controlled and used via the Internet. Additionally, there are two 120 square-foot storage buildings located on the subject parcel. The proposed expansion will be located on the same 4.95-acre parcel as the existing facilities and will be comprised of one 1,066 square-foot structure to be used as an employee breakroom utilized by up to two employees, four 672 square-foot structures, nine 1,200 square-foot structures, and eight 120 square-foot structures, each of which will be unmanned facilities containing telescopes and cameras remotely controlled and used via the Internet.

9. Surrounding land uses and setting: Briefly describe the project's surroundings:

The subject parcel is currently a wooded area composed of six observatory buildings and eight observatory units. The surrounding land uses consist of rural residential, agricultural land and open space.

Correspondence received from Santa Rosa Rancheria Tachi Yokut Tribe stating “*Due to the location of this project the tribe will be deferring to the more local tribes of the area.*”. No other correspondence was received from the Tribes prior to IS submittal.
