**NOTICE OF INTENT TO ADOPT
A NEGATIVE DECLARATION**

Public Resources Code Section 21092 and Cal. Code of Regulations Title 14, Section 15072 (the Guidelines for the California Environmental Quality Act) require a local agency to provide a notice of intent to adopt a negative declaration or mitigated negative declaration to the public, responsible agencies, trustee agencies, and the county clerk of each county within which the proposed project is located, sufficiently prior to adoption by the lead agency of the negative declaration or mitigated negative declaration to allow the public and agencies the review period provided under Section 15105 of the Guidelines.

Project Title: ENV-2022-6550-ND

Project Location: 3880 North Mission Road (3850-4108 North Mission Road) Los Angeles, CA 90031

Project Description: The Project would involve the import of approximately 344,000 cubic yards of soil to partially fill in a single-level subterranean parking level and basement areas associated with existing warehouse, logistics, light industrial and office buildings (the remainder of the fill will come from on-site sources). Any prior or subsequent development on the site is not a part of this Project. In order to allow for development of the Project, the Project Applicant is requesting a haul route for approximately 344,000 cubic yards of imported soil to the Project Site.

Schedule: The City of Los Angeles will receive comments on the Initial Study/Negative Declaration beginning June 15, 2023 for 20 days, ending July 5, 2023. The City of Los Angeles, as lead agency, will make a determination on the project, following a public hearing to be scheduled.
