NOTICE OF PUBLIC HEARING AND INTENT TO ADOPT A MITIGATED NEGATIVE DECLARATION

Dear Property Owner or Agency:

This notice is being sent to property owners within or near the area shaded on the attached map and to all public agencies who are reviewing agencies for this environmental document. The map shows the property, consisting of 2.06 acres, on which Center of Hope II LP is requesting approval of Use Permit Application UP-2022-01555 to construct a new 49-unit affordable apartment complex on property located at 2303 Alfreda Way. The site is zoned "RM-15" Residential-Multiple Family District with a General Plan designation of Residential — 10 to 20 Dwelling Units per Acre (10 to 20 u/a).

The City of Redding Planning Division has reviewed the project and, based upon the whole record before the City (including the Initial Study and any supporting documentation), is recommending that a Mitigated Negative Declaration* be adopted pursuant to the California Environmental Quality Act.

All interested persons are invited to comment in writing on the draft Mitigated Negative Declaration to the Planning Division prior to the end of the public review period. The comment period for the Negative Declaration begins June 21, 2023, and ends 5:00 p.m. on July 24, 2023. The Planning Commission will consider adopting the Mitigated Negative Declaration and will conduct a public hearing to consider approving the project at 4:00 p.m., Tuesday, July 25, 2023, in the City Council Chambers. Adoption of the Mitigated Negative Declaration will conclude the environmental review of the project.
