The purpose of the proposed project is to provide facilities to fully utilize recycled water produced by the LCSD's wastewater treatment plant, which would offset use of groundwater resources. The proposed project includes pipelines to connect the existing recycled water tank and pump station at Waller Park to existing ponds at the Santa Maria Country Club and valves at each pond to control inflow of recycled wastewater. Based on the existing production of recycled water by the wastewater treatment plant and commitments to provide recycled water to other users, the LCSD may only be able to meet a portion of the irrigation demand of the Country Club. However, production of recycled water may increase over time as development occurs in the LCSD service area and wastewater inflows to the wastewater treatment plant increase, which may allow a greater proportion of the Country Club's irrigation demand to be met.
