Project Title: T.O.R.O. LLC (Project)

Project Location: The Project is located at 1426 E HOBSONWAY, BLYTHE, CA 92225, in Riverside County.

County: Riverside

Project Description:

The Department of Cannabis Control, pursuant to authority granted under Business and Profession Code Division 10, Chapter 2, Section 26012, approved a Cannabis Distribution License submitted on 9/27/2022, by T.O.R.O. LLC.

Project Activities: The proposed project will operate a distribution license out of a newly constructed facility located at 1426 E HOBSONWAY, BLYTHE, CA 92225 (APN 854-040-027 &029). The applicant will store cannabis products for distribution in 15,300 square foot facility. Cultivation will also occur on site. The project has a General Plan and zoning designations of C-G (General Commercial) which allows for commercial cannabis businesses. The lot site is 1.5 acres, within the city of Blythe, and substantial surrounded by urban uses.

Reasons Why Project is Exempt:

The Department of Cannabis Control has determined that the project is a Class 32 Categorical Exemption Project. Class 32 Categorical Exemptions consist of being consistent with the City's General Plan and Zoning Code, located within the city limits, project is no more than five acres, substantially surrounded by urban uses, no value as habitat for endangered, rare, or threatened species, no result in any significant effects relating to traffic, noise, air quality, or water quality, and is adequately served by all public utilities. None of the exceptions to the exemption defined in Section 15300.2 apply to the Project.
