The Proposed Project is the Pacifica Housing Element Targeted General Plan Amendments and Rezoning Program (6th Cycle). The General Plan Amendments and Rezoning Program will create the regulatory framework to accommodate the Regional Housing Needs Allocation (RHNA) sites inventory and promote development of multi-family housing, including rental housing, missing middle housing, and mixed-use development. Along with rezoning specific sites in order to develop housing, the Proposed Project will also involve General Plan amendments to existing land use designations. As such, the Proposed Project addresses land use constraints to make the production of housing more likely. It reflects the priority given in the General Plan and Draft Housing Element to focus development in existing commercial shopping centers and other infill locations.
