Project Location: The Project is located at 196 UNIVERSITY PKWY, BLD G, POMONA, CA 91768-4300 in Los Angeles County.

Project Description:

The Department of Cannabis Control, pursuant to authority granted under Business and Profession Code Division 10, Chapter 2, Section 26012, approved a Cannabis Microbusiness License submitted on 12/28/2022, by UNITED POMONA.

Project Activities:

The proposed project will operate a microbusiness license out of an existing facility located at 196 UNIVERSITY PKWY, BLD G, POMONA, CA 91768-4300 (APN 8710-012-030). The applicant will store cannabis products for cultivation, retail, and distribution in 24,177 square foot facility. The site is consistent with the General Plan, is less than 5 acres, and can be served by all public services and utilities.

Reasons Why Project is Exempt:

The Department of Cannabis Control has determined that the project is a Class 32 Categorical Exemption Project. Class 32 Categorical Exemptions consist of being consistent with the City's General Plan and Zoning Code, located within the city limits, project is no more than five acres, substantially surrounded by urban uses, no value as habitat for endangered, rare, or threatened species, no result in any significant effects relating to traffic, noise, air quality, or water quality, and is adequately served by all public utilities. None of the exceptions to the exemption defined in Section 15300.2 apply to the Project.
