Project Location: Bridge #37C0501 is located on Alamos Road over Herbert Creek, approximately 0.7 miles west of Hicks Road.

Name of Public Agency Approving Project: Santa Clara County Roads & Airports Department

Description of Project: The Santa Clara County Roads & Airports Department proposes to remove bridge #37C0501 on Alamos Road over Herbert Creek and replace it with a new bridge. The replacement bridge will be a two-lane, clear-span structure on the same alignment. The project will require right-of-way and/or temporary construction easements to construct.

Name of Person or Agency Carrying Out Project: Santa Clara County Roads & Airports Department

Exempt Status: Class 2 - Section 15302. Replacement or Reconstruction of existing structures and facilities where the new structure will be located on the same site and will have substantially the same purpose and capacity as the structure replaced.

Reasons why Project is Exempt: The project is the replacement of an existing single-span bridge with a new single-span bridge at the same location with a greater width to accommodate two traffic lanes. Per Section 15300.2 of the CEQA Guidelines, it has been determined 1) no historic resources, hazardous waste sites, or scenic highways will be affected by the project, 2) no unusual circumstances are associated with the project, and 3) successive projects of the same type and in the same place would not occur as a result of the project.
