Project Location: The Project is located at 2608 Mission Street, Suite C, in Santa Cruz County.

Project Description:

The Department of Cannabis Control, pursuant to authority granted under Business and Profession Code Division 10, Chapter 2, Section 26012, approved a Specialty Indoor cannabis license submitted on 01/30/2019, by John Kelly CO.

Project Activities:

The Project will consist of 3,778 square feet of canopy cultivation, 1,630 square feet of immature plant cultivation, 283 square feet of processing/manufacturing, 411 square feet for drying, and 181 square feet of research & development and distribution. The location of the facility is in a portion of an existing structure located in an Industrial/Performance zoned district. Water will be supplied from a retail water supplier and power sourced from the grid.

Reasons Why Project is Exempt:

The Department of Cannabis Control has determined that the project is a Class 32 Categorical Exemption project. Class 32 consists of projects characterized as in-fill development meeting the conditions described in this section. (a) The project is consistent with the applicable general plan designation and all applicable general plan policies as well as with applicable zoning designation and regulations. (b) The proposed development occurs within city limits on a project site of no more than five acres substantially surrounded by urban uses. (c) The project site has no value, as habitat for endangered, rare or threatened species. (d) Approval of the project would not result in any significant effects relating to traffic, noise, air quality, or water quality. (e) The site can be adequately served by all required utilities and public services. The project site does not propose any expansion and None of the exceptions to the exemption defined in Section 15300.2 apply to the Project.
