The proposed Sandraya Heights Land Division (the project) is a Land Division to create nine single-family residential lots, on an existing 5.88-acre lot (the project site). The project site is located within the R-1-20 Single Family Residential Zoning District, which requires a minimum lot size of 20,000 square feet. The residential lots would range in size from 20,053 sf to 22,852 sf. Six of the proposed lots would be accessed via a new access road that would connect to Grace Way and Casa Way and would include a cul de sac and concrete driveway aprons. The remaining three lots would be accessed from a new cul de sac at the end of San Augustin Way.
