Re: Record Search Results for the Esperanza Village Project

The South Central Coastal Information Center received your records search request for the project area referenced above, located on the Orange, CA USGS 7.5' quadrangle. The following summary reflects the results of the records search for the project area and a ½-mile radius. The search includes a review of all recorded archaeological and built-environment resources as well as a review of cultural resource reports on file. In addition, the California Points of Historical Interest (SPHI), the California Historical Landmarks (SHL), the California Register of Historical Resources (CAL REG), the National Register of Historic Places (NRHP), and the California State Built Environment Resources Directory (BERD) listings were reviewed for the above referenced project site and a ¼-mile radius. Due to the sensitive nature of cultural resources, archaeological site locations are not released.

**HISTORIC MAP REVIEW** - Anaheim, CA (1896, 1942) 15' USGS historic maps indicate that in 1896 there was one building within the project area. There were two roads and several buildings within the project search radius which was located within the historic place name of Canon de Santa Ana. The Atchison Topeka and Santa Fe R.R. (San Diego and San Bernardino Branch) and Santa Ana River ran south of the project area. In 1942, there was no visible development within the project area. There were a few more additional roads, buildings and two intermittent streams within the project search radius. One road was renamed Highway 14. Levees were visible along the Santa Ana River. The rail line remained but was renamed as the Atchison Topeka and Santa Fe R.R. Also of note was a cemetery east of the project area.

**RECOMMENDATIONS**

*\*When we report that no archaeological resources are recorded in your project area or within a specified radius around the project area; that does not necessarily mean that nothing is there. It may simply mean that the area has not been studied and/or that no information regarding the archaeological sensitivity of the property has been filed at this office. The reported records search result does not preclude the possibility that surface or buried artifacts might be found during a survey of the property or ground-disturbing activities.*

The project location has not been previously surveyed for the presence of cultural resources. It appears that most of the natural ground surface within the project area is obscured by urban development; consequently, archaeological surface finds would be highly unlikely. However, based upon the known archaeological sensitivity in the surrounding area, buried prehistoric or historic cultural resources may be present. Therefore, in order to assess archaeological sensitivity, an archaeological monitor should be retained to monitor ground-disturbing activities. In the event that cultural resources are observed, all work within the vicinity of the find should be diverted until the archaeologist can assess and record the find and make recommendations. It is also recommended that any structures (45 years and older) be identified, recorded, and evaluated for local, state, or national significance prior to the approval of project plans as may be required by the lead agency. It is also recommended that the Native American Heritage Commission should be consulted to identify if any additional traditional cultural properties or other sacred sites are known to be in the area. The NAHC may also refer you to local tribes with particular knowledge of potential sensitivity. The NAHC and local tribes may offer additional recommendations to what is provided here and may request a survey and/or an archaeological monitor. Finally, if the built-environment resources on the property are 45 years or older, a qualified architectural historian should be retained to study the property and make recommendations regarding those structures.
