The Project site is developed with approximately 19,250 square feet (sf) of retail uses with multiple tenants in three buildings and a surface parking lot. The existing on-site structures would be demolished to allow for the construction of 44 multi-family attached townhomes at a density of 17 du/ac. Project entitlements include Vesting Tentative Tract Map 19161 to subdivide the Project site for condominium purposes and a Use Permit.
