The proposed project is a three-story (two-story of residential over a ground level parking garage), 43 foot in height, 25,214 square foot, nine unit multi-family residential building all on two lots totaling 16,645 square feet. The project is providing a total of 18 automobile parking spaces and 11 bicycle parking spaces. A total of 1,560 square feet of open space and 3,084 square feet of landscaping is proposed. The applicant is proposing the demolition of two single-family dwellings and two detached garages, 456 cubic yards of grading, and the removal of 17 non-protected trees. Five street trees on Sherman Way will be protected in place.
