The Department of Cannabis Control, pursuant to authority granted under Business and Procession Code Division 10, Chapter 2, Section 26012, approved a Cannabis License submitted on 12/31/2018, 01/12/2021, and 06/23/2023, by Stephen Kaye. Stephen Kaye applied for (12) Small Mixed-Light Tier 1, Nursery, and Processor license.

Project Activities:

The project consists of approximately 178,080 square feet of greenhouse space for mixed light commercial cannabis cultivation, and nursery operations within existing greenhouses and processing activities & non-volatile manufacturing operations within an existing 6,600 square commercial building. Water will be supplied from a ground water well and power sourced from the grid.

The project site does not propose any expansion and was formerly used for agricultural use. The project site is developed due to existing agricultural operations, no native vegetation and environmentally sensitive habitats are present on-site.
