The South Tahoe Public Utility District Board of Directors entered into a Power Purchase Agreement with Staten Solar for a solar project at the wastewater treatment plant. The ground mounted solar facility will be built on undisturbed forested lands to the east of the plant and will offset approximately one-third of the energy demands at plant beginning in 2024.
