 The Project proposes a new detention basin and a new storm drain pump station on two (2) parcels on 2.7 acres. The Project also proposes a storm drain interceptor from the basin, along Brownell Street, to the existing 36" drainage pipe between Fortuna and Terri Drive. The Project also proposed a parallel pipeline on Terri Drive and Mary Lane. The Project is designed to serve Drainage Zone R (tributary area) and runoff collected in the basin will discharge into the Merced Irrigation Canal.


