Project Location (include county): The project is located at an unnamed tributary to Marshall Creek, in the County of Sonoma, State of California; 29547 Bohan Dillon Road, Cazadero, CA, 95421; Assessor's Parcel Number (APN) 109-350-059; Section 31, Township 9N, Range 12W, U.S. Geological Survey (USGS) map Annapolis 7.5' Quadrangle, Mount Diablo Base and Meridian.

Project Description: The California Department of Fish and Wildlife (CDFW) has executed Lake and Streambed Alteration Agreement number EPIMS-SON-33931-R3 pursuant to section 1602 of the Fish and Game Code to the project Applicant, Matt Greene, Matt Greene Forestry & Biological Consulting.

This project proposes to dip out one existing dirt ford at a Class II watercourse crossing and install one temporary Spittler at a Class II watercourse crossing.

This is to advise that CDFW, acting as a Responsible Agency, approved the above described project on July 25, 2023 and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will / will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
