Present Land Use/Zoning/General Plan Designation: Commercial (Community Commercial) – Transit-Oriented Development (TOD)

Project Description: Murrieta Hot Springs at Jefferson Multi-Family Project: Quarterra, LLC (applicant) proposes implementing a 389-unit multi-family development on an approximately 18-acre site. The Project includes a Development Plan permit (DP 2022-2605) pursuant to Chapter 16.56, Development Plan Permits, of the City's Development Code. The multi-family units will be placed in 15, three-story buildings. Approximately 13 acres net of the site will be developed, with a five-acre area containing drainage and grasslands to be avoided by design and retained as open space. The Project includes frontage improvements to Jefferson Avenue and Murrieta Hot Springs Road with new ingress/egress driveways, lane improvements, striping, and sidewalks. The Project would provide 1, 2, and 3-bedroom apartments and on-site amenities for the residents. A total of 788 parking spaces would be provided (surface, carport, and garage). Sewer and water services are to be provided by Western Municipal Water District. Grading includes 14,900 cubic yards of cut, and 19,300 cubic yards of fill for a net import of 4,600 cubic yards of soil. The Property is zoned Community Commercial and is within a Transit Development Oriented Overlay District (TOD) which allows for multi-family residential when proposed at a minimum of 30 du per acre.


