Project Description

The California Department of Transportation (Caltrans) proposes to install a 6" PCC curb and to flatten the existing grade behind the proposed new curb. The 6" curb is necessary to prevent vehicles from parking and tracking mud into the SB On-Ramp from Elkhorn Blvd. Maintenance has placed no parking signs but it appears that tracking still continues and Maintenance has received several complaints.

Purpose: Sac-99 Elkhorn Park and Ride, install a 6" PCC curb and to flatten the existing grade behind the proposed new curb.

Need: The 6" curb is necessary to prevent vehicles from parking and tracking mud into the SB On-Ramp from Elkhorn Blvd (See page 3).
