Project Description:

The Department of Cannabis Control, pursuant to authority granted under Business and Procession Code Division 10, Chapter 2, Section 26012, approved and issued Cannabis Provisional License on 4/05/2022 to Craig Nejedly. Craig Nejedly applied for a Processor License in an indoor industrial metal building for the processing of cannabis product.

Project Activities:

The Project will consist of processing, distribution and manufacturing within an existing 10,000 s.f. metal building on a 1.3-acre parcel in an industrial zoned district in the City of Eureka in Humboldt County. Water is sourced from the City and power provided by PG&E.

Reasons Why Project is Exempt:

The Department of Cannabis Control has determined that the project is a Class 1 Categorical Exemption Project. Class 1 Categorical Exemptions consist of the operation, repair, maintenance, permitting, leasing, licensing, or minor alterations to existing public or private structures, facilities, mechanical equipment, or topographical features, involving negligible or no expansion of use beyond that existing at the time of the lead agency's determination. The Project involves the use of an existing industrial metal building. The design, location, size, and operating characteristics of the Project are compatible with the existing and future land uses within the vicinity as it is zoned industrial zoned. None of the exceptions to the exemption defined in Section 15300.2 apply to the Project.
