LOCATION:

The Sacramento International Airport (SMF) is located approximately 10 miles northwest of downtown Sacramento. SMF is generally bounded by Power Line Road to the east, Garden Highway to the west, Interstate-5(I-5)/Sacramento River to the west and south, and West Elverta Road to the north. The project site is located within the Taylor Monument U.S. Geological Service quadrangle: Townships 9 and 10 N, Range 3 and 4 East, Sections 13, 18, 19, 24, 25, 30, 31, 36, and 6.

GENERAL DESCRIPTION:

The project would provide a publicly-accessible Electric Vehicle (EV) charging facility that would be built on a 110-acre parcel of land adjacent to Interstate 5 (I-5 and proximate to State Route 99 (SR-99), both major freight corridors. Facility development would include the installation of Direct Current Fast chargers (DCFC) and Megawatt Chargers powered by a new solar array (solar fields on 96.5 acres) that would support charging for shippers and transporters as well as public transportation and passenger vehicles. The charging areas and associated support facilities would occupy 13.5 acres of land and would be configured with two truck charging areas with trailer parking stalls, separated by a publicly accessible central plaza. The central plaza will include three buildings - one for operations staff, one trucker refreshment/resting lounge, and one convenience store/restroom and visitor center.

This report identifies impacts that are less than significant with mitigation for impacts associated with air quality (short-term construction emissions), biological resources, cultural resources (archaeological resources, including human remains), transportation (design hazards or incompatible uses), and tribal cultural resources. The DSEIR identified significant and unavoidable impacts related to agricultural resources (farmland conversion).

The DSEIR identified significant or potentially significant impacts with air quality (short-term construction emissions), biological resources, cultural resources (archaeological resources, including human remains), transportation (design hazards or incompatible uses), and tribal cultural resources. which could be reduced to a less than significant level through inclusion of recommended mitigation measures.

Impacts associated with aesthetics, air quality (long-term operational emissions, toxic air contaminants, odors), climate change, cultural resources (historic resources), energy, hazards and hazardous materials, hydrology and water quality, land use, noise, transportation (conflict with transportation policies, vehicle miles traveled, emergency access), and utilities are considered less than significant.

The review period for the Draft Supplemental Environmental Impact Report begins 2-2-2024 and ends on 3-18-2024.
